Dagsorden

1. Godkendelse af dagsorden / Approval of agenda

Agenda approved.

2. Udsugning fra LAF-bænke i Bartholin / Extraction from LAF benches in Bartholin by Conor Leerhøy/Kim Henningsen

Conor explained how a LAF bench is not required to exhaust to the outside. 1/3 of air is drawn out, 2/3 of air is drawn through a HEPA filter. While the LAF bench is in use, air is drawn out. There is no guarantee that hazardous fumes do not escape out in the room. A LAF bench is not for working with hazardous chemicals. When working with hazardous chemicals a fume hood should be used as it then protects the employee. However, a fume hood is not for sterile work and therefore the LAF bench is sometimes used for work with hazardous chemicals.

All LAF benches are marked "No chemicals". It is important that users realize that the air is not drawn out of the building as it is in the Anatomy building. The question is if we should have another solution in Bartholin. Conor informs that there are LAF benches for class 2+ labs, but he does not know the specifications and it will need to be investigated. Another option is to designate a special LAF bench on each floor to work with hazardous chemicals. But no matter what the solution is it must be stated clearly what type of work can be done in the specific LAF benches.

Conor will send the data they have collected on the new type of LAF benches to Kim Henningsen.

Seventeen LAF benches will be moved from Skou to the Bartholin building.

3. APV 2025 / WPA 2025

The WPA focus group consist of the following members: Thomas G. Jensen, Birgitte Mønster Christensen, Lasse Sommer Kristensen, Agnete Larsen, Bertha Mortensen, Anne Lillevang and Ulla Vosegaard Als.

Birgitte informed LAMU of the initiatives that are planned in connection with the WPA. An article on the initiatives of the last WPA will be released on February 20. Thomas will also send a mail about it. During the answer period, the screens will be updated with the

answer rate regularly and if we reach a certain answer rate the employees will be rewarded (bread for breakfast). AMO representatives will be encouraged to be ambassadors for the WPA as the talk of the importance of completing the WPA questionnaire must be ongoing throughout the period.

4. Update på flytning til Bartholin og Skou / Update on move to Bartholin and Skou

The move to Bartholin is going according to the plan. The dates for the move to Skou are not yet planned, but as soon as the management has the dates, hopefully before the summer holidays, they will be communicated.

5. Update på klassifikation af lab i Bartholin / Update on classification of labs in Bartholin

Class 1 labs are approved. Class 2 is not approved yet, as the labs were not finished when the inspection took place. Another inspection of class 2 labs will take place closer to the date for moving in. Class 1/animal will be inspected by the Environmental Protection Agency (Miljøstyrelsen) on Thursday.

6. Evaluering af AMO-mødet i december 2024 / Evaluation of the AMO-meeting in December 2024

Although the content of the meeting was relevant, it was agreed that the meeting lacked educational content. A focus point on the next meeting could be LEAF, but all suggestions are welcome.

7. Behandling af ansøgninger til well-being arrangementer / Processing of applications for well-being events. (bilag 1-6)

LAMU received 6 applications for events. 4 events were approved by LAMU. One was partly approved as the concluding pizza dinner could not be approved and one could not be approved as it had no academic content. The applicants will be notified directly.

8. Fastsættelse af næste frist for ansøgning til well-being arrangementer/LAMU-møde (16/6-25) fx 1/6-25. / Setting of date for deadline for next application to well-being events/LAMU meeting (16/6-25) eg 1/6-25.

As the budget for the entire year will be used on this application round, it was decided that the next application - June 2025 - will be cancelled. This means that the next application round will be in one year. The next deadline for application will thus be January 15, 2026.

9. Orientering om arbejdsulykker siden sidste LAMU-møde / Information about occupational accidents since the last LAMU-meeting

Birgitte informed LAMU about the six occupational accidents since our last LAMU meeting:

- Mouse bite
- One hurt her/his arm as a trolley with IVC boxes overturned

- One got cut when performing an autopsy
- One got PFA over neck and chest as the container was not properly closed and the container was placed too high up on a shelf – placing things too high up must be avoided
- Hand got cut on the -80 freezer – gloves must be used. Gloves are already there, but there could be gloves in various sizes.
- A package was received with a broken glass tube. The glass tube contained white powder. As soon as the person opening the package realized that the tube was broken, (s)he correctly took it to the fumehood.

11. Evakueringsøvelse – Fastsættelse af tidspunkt / Evacuation drill – setting of date
